

**AGREEMENT\CRUDE OIL & \OR OTHER HYDRO-CARBONS PIPE LINE**

**WHEREAS**, the **PROPERTY OWNER** desires to construct an **Crude Oil &lor Other Hydro-Carbons Pipe Line** on and under the **County** Road between Section \_\_\_\_\_ and Section \_\_\_\_\_, of Township \_\_\_\_\_, Range \_\_\_\_\_, Merrick County Nebraska, for the transmission of **Crude Oil &lor Other Hydro-Carbons Pipe Line** and seeks permission from the **County** to cross its roadway, and

**NOW, THEREFORE**, for and in consideration of the sum of One Dollar (\$10.00) paid to the County by said **Property Owner**, the receipt of which is hereby acknowledged, the **County** does hereby grant to said **Property Owner**, their heirs and assigns, the right to construct, install, maintain and operate an **Crude Oil & \or Other Hydro-Carbons Pipe Line** for the transmission of **Crude Oil &lor Other Hydro-Carbons Pipe Line** on and under the public highway and right-of-way, approximately \_\_\_\_\_ feet \_\_\_\_\_ of the \_\_\_\_\_ Corner of said Section \_\_\_\_\_, : upon the following conditions, to wit

**PURPOSE FOR PERMIT :** \_\_\_\_\_

- A. Property Owner** agrees to bury all **Crude Oil &lor Other Hydro-Carbons Pipe Line** at least \_\_\_\_\_ inches below the surfaces of the roadway;
- B. Property Owner** agrees to replace the surfaces of said roadway and leave the same in as good a condition as existed immediately prior to the installation of said **Crude Oil &lor Other Hydro-Carbons Pipe Line**;
- C. Property Owner** agrees to exercise due care and diligence to avoid injury or damage to the property or others;
- D. Property Owner** agrees that they will protect, save and hold harmless and indemnify the County from any and against all liability, loss, damage and expense suffered by or imposed on the County by reason of the construction, installation and maintenance of said **Crude Oil &lor Other Hydro-Carbons Pipe Line**;
- E. Property Owner** agrees to so construct said **Crude Oil &lor Other Hydro-Carbons Pipe Line** that it will not interfere with the drainage in natural or constructed water courses;
- F. Property Owner** agrees that should the **County** desire to relocate or improve said roadway, that said **Property Owner** will cause said **Crude Oil &lor Other Hydro-Carbons Pipe Lines** to be relocated at his expense.

It is further understood and agreed by the parties hereto that should said **Crude Oil &lor Other Hydro-Carbons Pipe Line** be abandoned by the **Property Owner** for a period of two years, the right-of-way or easement hereby secured shall then cease and termin and the **Property Owner** agrees to promptly remove said **Crude Oil &lor Other Hydro-Carbons Pipe Line** and replace the roadway in as good a condition as it was immediately prior to said removal.
