



November 12, 2013

The Merrick County Board of Supervisors met Tuesday, November 12, 2013 at 9:05 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Graves, Helgoth, Hahn, Jefferson, Kucera, Weller and Wiegert present. Also present was County Attorney Lynelle Homolka.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:05 a.m.

Moved Hahn, second Helgoth to convene as Board of Supervisors at 9:05 a.m. Roll Call: All Ayes

Agenda: Moved Kucera, second Graves to approve the agenda as presented. Roll Call: All Ayes.

Minutes: Moved Graves, second Helgoth to approve the minutes from October 22, 2013 as presented. Roll Call: All Ayes.

Meeting Reports: Graves attended a hospital board meeting on October 23, 2013; Weller attended an Economic Development meeting where they discussed the Merrick Manor; Jefferson attended the Keystone Pipeline meeting in Clarks; Kucera attended a Region 3 meeting and Wiegert attended a Midland Area on Aging meeting.

Official reports: Weed Superintendent Corwin Roscoe said there is a conflict going about the river. They are going to have the property owners along the river split the cost for spraying somehow. They are still working on this matter. Cindie Hostler from the Extension Office said she was in charge of the Courthouse Thanksgiving dinner and this year she is doing a potluck. She invited all the Supervisors and their spouses. It will be held Tuesday, November 26, 2013 at noon. Tammy Stuhr said they had their annual achievement award night and that the 4H Council has put a tree and bench at the fair grounds in remembrance of Tyler Hillmer. Tammy, Troy, and Jeanette will all be in Kearney the rest of the week for their annual meeting and from there Tammy will be going to Boston for a meeting. The Extension Board meeting will be on November 19, 2013 because all three of the educators will be in Kearney this week. They will be replacing a board member so asked the County Board if they know of anyone that may be interested. Treasurer Bolte gave the Board a copy of the collections and disbursements for October, 2013. Collections are slow right now and that is expected. Planning & Zoning Myers said that the Board should have all received letters on the Ag Friendly. She is planning a meeting with the Governor and inviting most of the agricultural businesses in the area. She said it is looking like a January meeting. Attorney Homolka said that she did complete the assist grant and it had been submitted. They are applying for 80% of the cost to install three new security cameras. Her Child Support worker Richard Wischmeier is retiring at the end of the year.

Brite Express: Attorney Homolka said that Brite Express did sign a new extended contract. Brite Express submitted a bid for the third floor to strip the floor tile and the mosaic tile and apply three coats of product. Their product is a self leveling product. It will take them about five hours to do and would probably do it on a Saturday. The bid is for \$622.40. Moved Weller, second Graves to approve and accept the bid for \$622.40 to refinish the third floor tiles by Brite Express. Roll Call: All Ayes.

NIFA grant: Planning & Zoning Myers said the grant has been declined but she will try again. They lost points in the matching dollars, the grant is done on a ten point system. Myers said that now the County is matching \$28,500.00 and if they would match with \$28,501.00 it would bring them so much closer to getting the grant accepted. Moved Weller, second Helgoth to increase the matching dollars for the County to \$28,501.00 for the NIFA grant match. Roll Call: All Ayes.

Electrical Agreement: Highway Superintendent Meyer needs the Board's approval for an Electrical Agreement for Mike Reeves between Section 36 and Section 31, Township 14, Range 6. It is for irrigation and Galusha Electric will install it. Moved Weller, second Graves to approve the Electrical Agreement. Roll Call: All Ayes.

RESOLUTION 2013-36: Moved Jefferson, second Weller to approve RESOLUTION 2013-36 to close 22nd Road between Section 15, Township 14, Range 5 and Section 16, Township 14, Range 5 beginning at the North R.O.W. line of Hwy 30 at the Union Pacific Railroad crossing on 22nd Road going North 1800 feet to State Hwy 92 with the conditions that at least 8 foot minimum of the East and West shoulders of 21st Road between Hwy 30 and Hwy 92; and the grading and placement of gravel on R Road between 20th Road and 21st Road before the closing of the road. Roll Call: Ayes: Hahn, Graves, Helgoth, Weller, Jefferson, and Wiegert. Nays: Kucera. Kucera said she was in favor of widening the shoulders but not closing the road. Helgoth wanted

Interlocal with Chapman: Highway Superintendent Meyer presented an Interlocal Agreement between Merrick County and the Village of Chapman for snow removal. Moved Jefferson, second Hahn to approve the Chairman signing the Interlocal Agreement for snow removal between Merrick County and the Village of Chapman. Roll Call: All Ayes.

Easement for Merrick Foundation: Chuck Griffith with Merrick Foundation had presented a survey done by County Surveyor Meyer for an easement from the Foundation's land north of Bader Park to the Wood River. Griffith was asking for the Board's approval of the easement. Moved Graves, second Jefferson to approve the easement from the Foundation's land north of Bader Park that extends south into Bader Park giving the Foundation access to the Wood River. Roll Call: All Ayes.

USA Communications: The Board would like to review the contract with USA Communications that the County has and asked to have this put on the next agenda.

County Government Day: Cindie Hostler in Extension said they are still waiting to hear back from Probation. Probation would like to be part of County Government Day but with the territory they cover they were not sure there would be anyone here. County Court will not be participating this year.

Fees: The October 2013 fees from the Sheriff, Clerk of District Court, and County Clerk were presented to the Board for their approval. Moved Weller, second Graves to approve the October 2013 fees from the Sheriff, Clerk of District Court, and County Clerk. Roll Call: All Ayes.

Salaries: Weller suggested a 2% increase each year for the elected officials, a 1.75% increase or a 1.5% increase. Discussion on the making the County Attorney's position full time and asking the County Attorney to draw up a resolution for the Board for the next meeting to set the salaries of the elected officials. Clerk Wichmann told the Board that they will be setting the salaries at the next meeting next week Thursday, November 21, 2013 so that she will know what the filing fees will be for persons filing for office.

Emergency payroll warrant: An emergency payroll warrant was presented to the Board for approval for General: Gross: \$296. 63 Net: \$260.59 that was inadvertently shorted on the last payroll. Moved Weller, second Graves to approve the emergency payroll warrant as presented. Roll Call: All Ayes.
