It is further understood and agreed that said Grantee will contact "Diggers Hotline" prior to any construction activities and agrees to replace the surface of the roadways which were disturbed in construction of said driveway entrance, and to leave said roadway in as good a condition as existed immediately prior to the installation of said driveway entrance. Appropriate construction signing shall be utilized during the construction of said driveway to warn the motoring public of construction activities. Grantee is responsible for all expenses incurred for the construction and future maintenance of said driveway. Final approval of the road to be given by the Merrick County Highway Superintendent after the Construction of the Driveway Entrance.

The Grantee agrees to indemnify and hold harmless, protect and defend the County and its elected and appointed offices, employees, agents, and representatives against any and all claims, demands, suits, actions, payments and judgements, including any and all costs and expenses connected therewith, legal cost or otherwise, for any damages which may be asserted, claimed, or recovered against or from the County or its insurers, because of personal injury, including bodily injury or death, or on account of property damage, including loss of use thereof, sustained by any person or persons which arises out of, is in any way connected with, or results from any and all work or activity associated with this agreement.

The Grantee also agrees to build the driveway entrance with the size and type of drainage culvert as specified by Merrick County and to flag location and provide a driveway location map. One (1) twenty four foot culvert per parcel will be provided by the county as long as it is for placement in County Right-of-Way.
