WHEREAS, the Grantee is preparing to construct a certain Gas Line within said County of Merrick, for ingress and egress Gas Line within said County and desires to construct a portion of said Gas Line upon and along the right-of-way of certain public roads within said County,

NOW THEREFORE, in consideration of the mutual promises and agreements herein, the County hereby grants to the Grantee the right, under the supervision and direction of the County Highway Superintendent or Assistant, to construct and maintain said Gas Line from County Road right-of-way and County Road \_\_\_\_\_ to Grantees property located as follows:

It is further understood and agreed that said Grantee will contact "Diggers Hotline" prior to any construction activities and agrees to replace the surface of the roadways which were disturbed in construction of said Gas Line, and to leave said roadway in as good a condition as existed immediately prior to the installation of said Gas Line. Appropriate construction signing shall be utilized during the construction of said Gas Line to warn the motoring public of construction activities. Grantee is responsible for all expenses incurred for the construction and future maintenance of said Gas Line. Final approval of the road to be given by the Merrick County Highway Superintendent after the Construction of the Gas Line.

The Grantee agrees to indemnify and hold harmless, protect and defend the County and its elected and appointed offices, employees, agents, and representatives against any and all claims, demands, suits, actions, payments and judgements, including any and all costs and expenses connected therewith, legal cost or otherwise, for any damages which may be asserted, claimed, or recovered against or from the County or its insurers, because of personal injury, including bodily injury or death, or on account of property damage, including loss of use thereof, sustained by any person or persons which arises out of, is in any way connected with, or results from any and all work or activity associated with this agreement.
