The Merrick County Board of Supervisors met Tuesday, September 10, 2019 at 9:05 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Kucera, Kreachbaum, Dexter, Yrkoski, Placke, Weller, and Wiegert present. County Attorney Homolka was also present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and the Merrick County Website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:19 a.m.

Moved Placke, second Kucera to convene as Board of Supervisors at 9:19 a.m. Roll Call: All Ayes Katie Benner announced that she was going to be facebook streaming live during the meeting.

Agenda: Clerk Wichmann announced the agenda needed to be amended because she had accidently delete the budget hearing for the Vieregg Township. Moved Kucera, second Kreachbaum to amend and add the Vieregg Township budget hearing at 10:45 a.m. to the agenda due to the emergency nature of the issue given the deadline of the submission of the Vieregg Budget to the state by September 20, and which is prior to the next regular scheduled board meeting and further the issue was previously published for hearing today at 10:45 a.m. Roll Call: All Ayes.

Minutes: Placke said there were two errors in the minutes of August 27, 2019. The first on was in the Sheriff's report it should say theft not left and below that it has the word direct two times. Moved Dexter, second Kucera to approve the minutes of August 27, 2019 with the corrections. Roll Call: All Ayes.

Meeting reports: Weller, Dexter, Placke, Yrkoski, Kreachbaum, and Wiegert attended the Drug Court Graduation on Monday, September 9, 2019; Dexter attended the Merrick County Economic Development meeting on Friday, September 6, 2019 and had a phone meeting at 2:00 p.m. on Friday, September 6, 2019 with SCEDD; Placke and Dexter met to go over security; Kucera said her Region III was cancelled. Kucera said that Sheriff Westman presented awards at the Equestrian Special Olympics at the 4H Arena and presented the first ever Wounded Warrior award. Kucera said the law enforcement participation is appreciated and Wiegert attended the Midland Area on Aging meeting on September 5, 2019. Official's reports: Hwy Superintendent Meyer said there were a lot of drainage issues last week and he is going to contact the NRD about cleaning drains. Meyer said he has ordered culverts for the road by Roger Wiegert and that 5th Road is closed because three culverts washed out. They will be replacing them. Juvenile Diversion Officer McNeff said Aurora Schools are now part of their truancy program. Clerk Wichmann said Central District Health will be giving flu shots to the employees on October 21, 2019 from 9:00 a.m. to 3:00 p.m. and she will be putting out an email to all officials, so they can let their employees know. County Attorney Homolka said there are two foreclosure sales that are possibly going to be redeemed. Homolka said there was a Comprehensive Plan meeting with Juvenile Diversion and Truancy. Homolka also handed out to the Board a list of case file numbers and feels it is due to the good work the law enforcement is doing. Chief Deputy Benson said that Officer Dickhaut had been injured while on military duty and will

Clerk surplus: Moved Placke, second Kucera to have the County Clerk surplus a Dell Opti Plex 3020 Computer and a 20 inch monitor purchased in 2014 that does not work properly. Roll Call: All Ayes.

have to have surgery, so he will be out for about six months.

Clerk Magistrate surplus: Moved Placke, second Kucera to have the Clerk Magistrate surplus an old shredder to the Road Department. Roll Call: All Ayes.

Juvenile Diversion: Moved Placke, second Dexter to have the Juvenile Diversion Officer surplus a HP Officejet pro 8600 printer. Roll Call: All Ayes.

Budget hearing: Moved Kucera, second Kreachbaum to open the budget hearing to hear support, opposition, criticism, suggestions or observations of taxpayers relating to the 2019-2020 fiscal year budget at 10:00 a.m. Lori Sautter went over what Hall County did for budget cuts, Keith Brown read his concerns to the County Board regarding the budget meeting/workshop, Jan Placke said that officials were given some guidelines, the print of the preliminary budget was too small, Sheriff's budget was over 3% and thinks it needs to be looked at, and thinks the budget process could be done better. Leah Brown told the Board that as they are making decisions consider that it is not just how they affect the levy and budget for this year but for years to come.





Katie Benner thanked the Board for their time and was glad there were people in attendance. Chief Deputy Benson came forward and said in the previous year there were two jailers that were paid from a different budget and this fiscal year they will be paid out of the communication budget and should have been paid out of the jail budget because we no longer have dispatch and these two are jailers and will be paid out of the jail budget this budget year. Kucera asked Benson about eliminating a deputy. Benson said they have 9 sworn officers now and often during day shift on a court day they have no one taking calls or the calls have to wait. They need at least two officers in the courtroom when inmates are there waiting for their case to be called and cannot use correction officers because the judge does not like that. Also have had three doing transports at a time to different locations. Inmates are housed outside of Merrick County because we have an eight bed jail and by current jail standards it would be six. Benson feels spot is needed and justified. At night sometimes there is only one deputy on duty. There are currently twelve inmates in Buffalo County, one in Butler County and seven in the Merrick County jail. County Court video conferencing is only done with bond reviews. Placke asked if Hall County could take the inmates and Benson said their prices are very expensive and the medical bills were bad, but Buffalo County has doctors and medical. Katie Benner said liability is a big issue. Moved Placke, second Kreachbaum to close the hearing at 10:43 a.m. Roll Call: All Ayes.

Budget authority: Moved Kucera, second Yrkoski to approve the 1% budget authority increase for restricted funds for the 2019-2020 fiscal year budget. Roll Call: All Ayes.

Tax request hearing and Budget adoption: Moved Placke, second Kucera to open the hearing to set the tax request for fiscal year 2019-2020 and sign RESOLUTION 2019-18 Adoption and Appropriations at 10:52 a.m. Roll Call: All Ayes. Moved Kucera, second Kreachbaum to go out of the hearing at 11:01 a.m. Roll Call: All Ayes. Moved Kreachbaum, second Kucera to set the tax request at .245969. Roll Call: Ayes: Dexter, Yrkoski, Weller, Kucera, Kreachbaum, and Wiegert. Nays: Placke.

Moved Kucera, second Kreachbaum to approve and sign RESOLUTION 2019-18 Adoption and Appropriations adopting the 2019-2020 budget. Roll Call: Ayes: Yrkoski, Dexter, Weller, Kreachbaum, Kucera, and Wiegert. Nays: Placke.

Subdivision Regulations hearing: Moved Kreachbaum, second Kucera to open the hearing to consider an amendment to the Merrick County Subdivision Regulations to eliminate the requirement of a public hearing for both Preliminary and Final Plats at 11:26 a.m. Roll Call: All Ayes. Placke suggested a public hearing for the Planning Commission for the preliminary plats and a public hearing for the County Board on the final plats. Moved Kucera, second Weller to go out of the hearing at 11:56 a.m. Roll Call: All Ayes. Moved Kucera, second Dexter to table and go back to the Planning Commission with a public hearing for preliminary and agenda item for final and an agenda item for the County Board. Roll Call: All Ayes.

Cedar Estates Subdivision: Moved Kucera, second Yrkoski to approve the final plate for Cedar Estates located on the south side of Capital Avenue and east of Evergreen Street. Roll Call: All Aves.

Administrative Plat Exemption: Moved Kucera, second Kreachbaum to approve the exempt administrative plat of property owned by Ted Dexter in the NW ¼ of Section 18, Township 14, Range 5. Roll Call: Ayes: Weller, Kucera, Yrkoski, Kreachbaum, Placke, and Wiegert. Nays: None. Abstain: Dexter.

Security: Dexter and Placke met and discuss the camera, panic buttons, and back door. Dexter talked to Johnson Controls about the panic buttons and the back door for \$500.00 and Applied Connections for the cameras and everything else. Clerk Magistrate Pullen said the back door is handled by Johnson Hardware and they do not do security. Placke and Yrkoski rescinded their motion.
