

Merrick County Board Minutes



March 24, 2020

The Merrick County Board of Supervisors met Tuesday, March 24, 2020 at 9: a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Kucera, Yrkoski, Dexter, Kreachbaum, Weller, and Wiegert present. Placke was absent. County Attorney Homolka was also present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and the Merrick County Website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9: a m

Moved Weller, second Yrkoski to convene as Board of Supervisors at 9:17 a.m. Roll Call: All Ayes

Agenda: Moved Dexter, second Kreachbaum to approve the agenda for March 24, 2020. Roll Call: All Ayes.

Minutes: Moved Dexter, second Yrkoski to approve the minutes from the March 10, 2020 meeting. Roll Call: All Ayes.

Meeting reports: Dexter, Kucera, and Wiegert attended the personnel meeting on March 17, 2020 and Yrkoski had a phone conference with Nebraska Action Partners.

Official's reports: Sheriff Westman said he is taking precautionary steps, putting out memos and having trainings for the Coronavirus. Attorney Homolka said she is working with the law enforcement and there are new executive orders from the Governor all of the time. Treasurer Gilg reported she had a tax sale on Monday, March 2, 2020 for years 2018 and prior. They collected almost \$133,000.00 prior to the sale and feels that it was due to sending out post cards. Assessor Myers said that March 19 is when all values have to be sent into the Department of Revenue. Ag land will go down and residential has to be increased and commercial was also increased. TVI be talking to the owners about their land values. Silver, Creek, Clarks, and Chapman are now all on square foot values. Clerk Wichmann said the drop boxes had come in for the courthouse and jail.
