The Merrick County Board of Supervisors met Tuesday, January 12, 2021 at 9:00 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Kreachbaum, Weller, Kucera, Dexter, Yrkoski, Placke, and Wiegert present. County Attorney Lynelle Homolka was also present.

Public comment: Hospital Administrator, Patrick Avila gave an over view on the hospital and on how the construction was going along on the new hospital.

Executive session: Moved Kucera, second Dexter to go into an executive session at 9:42 a.m. for the protection of the public interest and for discussion of security personnel or devises. Roll Call: All Ayes. Moved Kucera, second Dexter to go out of executive session at 10:34 a.m. Roll Call: All Ayes.

Electrical agreement: Moved Kucera, second Yrkoski to approve and sign the electrical agreement between Merrick County and Polk County Rural Public Power District for an underground crossing for a distribution line on the north side of the intersection between Sections 18 and 19, Township 15N, Range 4W. Roll Call: All Ayes.

Electrical agreement: Moved Placke, second Dexter to approve and sign the electrical agreement between Merrick County and Polk County Rural Public Power District for an underground crossing for distribution line across the East and West roads between Section 18 and 19, Township 15N, Range 4W. Dispatch interlocal: County Attorney Homolka said that Hamilton County had rejected Merrick County's counter offer and came back with the following: Merrick County would pay Hamilton County \$165,000.00 for the first year. The two Counties shall agree that subsequent payments are to be reviewed annually and adjusted for years two and three of the agreement. Both parties would meet to review the costs in November of each year of the agreement to set the fee for the coming calendar year. And in paragraph two change to: move the meeting from monthly to quarterly and in paragraph five remove Hamilton County has complied with this paragraph. Merrick County will counter with Merrick shall pay to Hamilton on an annual fiscal year basis beginning January 1, 2021 the sum of \$165,000.00 in return for Hamilton to provide the services herein, subject to review annually in March and adjustment upon approval by each respective County Board and in paragraph five to say Hamilton shall update and maintain the software for the records management system, known as Justice Data Solutions, and update and maintain the mapping program for so long as this agreement is in effect.
