



March 9, 2021

The Merrick County Board of Supervisors met Tuesday, March 9, 2021 at 9:06 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Kucera, Yrkoski, Placke, Dexter, Weller, Kreachbaum and Wiegert present. County Attorney Homolka was also present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and the Merrick County Website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:06 a.m.

Moved Kreachbaum, second Yrkoski to convene as Board of Supervisors at 9:06 a.m. Roll Call: All Ayes

Agenda: Moved Dexter, second Placke to approve the agenda as presented. Roll Call: All Ayes.

Minutes: Moved Dexter, second Kucera to approve the minutes of the February 23, 2021 as published. Roll Call: All Ayes.

Meeting reports: Weller attended the Central District Health meeting on Monday, March 8, 2021; Dexter attended the Merrick County Economic Board meeting on March 5, 2021; Kreachbaum had a Mid Plains Behavior meeting on February 17, 2021 and attended the quarterly meeting with Boone, Nance, and Merrick Counties and the Emergency Manager on February 22, 2021; Kucera had an Extension Board meeting on March 3, 2021 but was unable to attend, and Wiegert had a NRD meeting on February 25, 2021.

Official's reports: Treasurer Gilg had a tax sale on March 1, 2021 and they did send out post cards and had time to make follow up calls. Gilg reported that \$212,000.00 of delinquent taxes have been paid for January 1 to the date of the sale. There were 52 parcels on the sale and 15 bidders that showed up. Emergency Manager Ziemba had a PET region meeting yesterday and there was a cyberattack on the Platte County Courthouse. PET is working on a grant for IT personnel and cyber security for all the counties in the PET. The LEOPS will be in electronic form from now on. Patrick Avila, Merrick Medical Center CEO gave a construction update on the new hospital and said that 95 plus percent of the steel work is complete. They are working on finalizing the landscaping for the Dinsdale Wellness campus. County Attorney Homolka said this would be her last meeting with the County Board.

Gas line agreement: Moved Kucera, second Yrkoski to approve and have the Chairman sign the Gas Line Agreement between Merrick County and Terry Blauhorn to replace shallow section of existing gas line going under County road & R.O.W. that feeds Blauhorn's home and several wells in Section 1, Township 14, Range 8 and Section 6, Township 14, Range 7. Roll Call: All Ayes.

Gas line agreement: Moved Weller, second Dexter to approve and have the Chairman sign the Gas Line Agreement between Merrick County and Terry Blauhorn to install 1 ¼ " gas line and tracer wire for 2 irrigation wells. Road crossing will be directionally bored in between Section 2 & 11, Township 14, Range 8. Roll Call: All Ayes.

Electrical agreement: Moved Dexter, second Yrkoski to approve and have the Chairman sign the electrical agreement between Need Board approval of an Electrical Agreement between Merrick County and Dale Morris to bury and electric line between Sections 6 & 7, Township 14, Range 4.

Electrical agreement: Moved Dexter, second Kreachbaum to approve and have the Chairman sign the electrical agreement between Merrick County and Les Denning to eliminate overhead lines and bury electrical in the ground between Sections 25 Township 15, Range 6 and Section 30, Township 15, Range 5.

Resolution 2021-4: Moved Kucera, second Kreachbaum to approve and have the Chairman sign RESOLUTION 2021-4 directing the transfer of funds from the Road Fund to the Inheritance Funds in the amount of \$350,000.00 that was borrowed. Roll Call: All Ayes. RESOLUTION 2021-4 is on file in the County Clerk's Office for public viewing.

Pledge securities: Treasurer Gilg presented the pledge securities and said that Cornerstone Bank was offering better interest. Moved Kreachbaum, second Dexter to approve the Pledge Securities presented by the County Treasurer. Roll Call: All Ayes.





Timberlake Road: Doug and Carolyn Pence, 1835 Timberlake Road, came and asked the County Board for help in getting their road fixed. Mr. Pence said that the road to the east was Hamilton County and the road to the west was Merrick County's. The road is impassible and there is no crown. Trains have blocked the road for three days at times so they couldn't go west. Mr. Pence said his concern is if something were to happen to him and or his wife or they had a fire, emergency crews would not be able to reach them because of the road conditions. They have complained to Hamilton and cannot get a response. Mr. Pence was not getting any response from Merrick County until he called Carolyn Kucera and she helped get some rock on the road. Mr. Pence said kids tear up the road and if barricades are put up they tear them down and steal the sand bags. County Attorney Homolka told the Board, the Board could write a letter to the railroad and the Pence's should keep a record of when this happens and report to law enforcement. Homolka also advised that if the Board and the Pence's' do not get any results from the railroad about the blocking of the road with the train they should contact the Department of Transportation. The Pence's are meeting with the Hamilton County Commissioners next week and Homolka thought it was a good idea if a board member or members and Highway Superintendent Meyer would attend.
