Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office. Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:00 a.m.

Kreachbaum-August 7th met with the CEO from Mid-Plains. All Supervisors attended Mike Meyers retirement party as Highway Superintendent on the 28th of July.

Officials Reports: Assessor Myers reported the certifications of value should be available to all political subdivisions by the first part of next week. She also informed the board that NACO is working on providing a document to explain which office has what role in the handling of the public hearing postcards. Clerk Strobel informed the board the NPERS exit audit report was complete with one finding relating to retirement not taken out for budget work payments of a former employee. Ballots for the Special Election for the Twin River School Bond will be mailed out on August 21st. Budget information has been handed over to Mitch Inmann with Dana Cole & Associates for review.
