The Merrick County Board of Supervisors met Tuesday, August 22, 2023 at 9:00 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Kreachbaum, Dexter, Jarecke, Placke, Kucera, Wiegert, Weller, County Attorney Kunz and County Clerk Strobel present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil, The Palmer Journal and the Merrick County Website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office. Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:04 a.m.

Moved Kreachbaum, second Placke to convene as Board of Supervisors at 9:04 a.m. Roll Call: All Ayes Moved Jarecke, second Kucera to approve the agenda with the amendment of County Surveyor contract to be Bridge Contract. Roll Call: All Ayes.

Moved Jarecke, second Dexter to approve the minutes August 8, 2023 as published with the correction of Board of Supervisors instead of Board of Equalization. Roll Call: All Ayes.

Treasurer Gilg reported that \$50,000 was received from the Local Assistance and Tribal Consistency Fund was received. Gilg also spoke with the State Auditors regarding District Courts outstanding balance of \$30,500.00 dating back to 1995. Surveyor past due accounts letters have been mailed with Townships and Highway Department past due accounts going out later today. A check was received from the Opioid Settlement and Gilg is looking into whether this would be able to be used toward mental health budget requests. Emily Soll, Extension Educator, provided a quarterly update. Brent Kunze, Highway Superintendent discussed with the board possible equipment needs as well as succession planning for employees. Kunze also stated Rod Bergmark retired August 21, 2023. Pivot violations were also discussed with County Attorney Kunz saying he would send out letters to those violators. Brent Kunze stated he began as Highway Superintendent on August 14th after the retirement of Mike Meyers on July 31, 2023.
