The Merrick County Board of Supervisors met Tuesday, March 11, 2025 at 9:05 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Kreachbaum, Jarecke, Dexter, Wiegert, Jarecke, Kucera, Weller, County Clerk Strobel and County Attorney Kunz present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and the Merrick County Website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were given to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairwoman Kucera declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:05 a.m. Moved Kreachbaum, second Wiegert to convene as Board of Supervisors at 9:05 a.m. Roll Call: All Ayes

Handbook meeting February 25th-Jarecke, Kreachbaum; Problem Solving Court Graduation March 3rd-Dexter, Wiegert, Jarecke; Dexter-Zoom teams meeting with Five Nines March 4th and Merrick County Economic Development on March 6th; Jarecke-CNCAP meeting March 10th; Kreachbaum conference calls with Mid-Plains throughout the week; Wiegert-Midland Area on Aging March 6th.
