At the request of a board member, Sheriff Westman presented a report regarding other counties and cities/villages dispatch procedures by population. No action required at this time.

Highway Superintendent Kunze supplied the board members with a hand out with drawings for potential satellite shops. Long term goals for Kunze are to have buildings in Archer, Chapman and Clarks. The board would like Kunze to put out for bids to know what finances would be needed in order to proceed with a project of this size.

Kunze discussed a structure bridge replacement at 22nd and AA Road. Recommended cost for option 1concrete box culvert with two to three piers \$651,000.00; option 2-clear open span bridge, no piers \$900,000.00 and option 3-steel structure precast concrete \$375,000.00. No action taken at this time. Kunze also brought up a structure for a low water crossing on 30th Road that needs addressed. No action taken at this time.

Kunze also spoke regarding concerns of the minimum maintenance road on 7th. No action required. Moved Weller, second Wiegert to terminate the Five Nines contract and direct County Attorney Kunz to draft a letter to Five Nines terminating the contract. Roll Call: All Ayes
