Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and the Merrick County Website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were given to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairwoman Kucera declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:09 a.m.

Moved Placke second Jarecke to convene as Board of Supervisors at 9:09 a.m. Roll Call: All Ayes Agenda: Moved Dexter, second Placke to approve the agenda. Roll Call: All Ayes

Minutes: Moved Dexter, second Jarecke to approve the minutes from June 22, 2025 as published. Roll Call: Ayes-Weller, Placke, Wiegert, Kreachbaum, Dexter, Jarecke; Abstain: Kucera. Motion carried. Meeting Reports: Drug Court graduation July 7-Weller, Dexter and Wiegert; Senior Board meeting June 25 and CNCAP zoom meeting June 30th-Placke; June 30 CNCAP-Jarecke; Kucera met with

Highway Superintendent Kunze regarding road conditions after heavy rainfall.

Officials Reports: Treasurer Gilg reported the county is down to four county tax sales. Highway Superintendent discussed the heavy rainfall effect on roads.

Tyson Benner approached the board during public comment. Benner stated he strongly feels the county needs to look into hiring either a full-time or part-time administrator to help organize and prioritize, as he feels there is a lack of efficiency.

Deputy Director Jon Cannon with NACO addressed the board with legislation updates, as well as services provided to counties.

First Light Child Advocacy Interim Director, Julissa Rivera, approached the board for a request of support in the amount of \$5,500.00. No action needed.

Hallie Razo, representing Willow Rising, Inc. requested \$3500.00 for annual support from the board. No action needed.

No discussion regarding Long Term Care.

Travis Maresh informed the board he may be interested in purchasing the old hospital in the future. No action required at this time.

Andy Forney with D.A. Davidson appeared before the board to explain the procedures and obligations for a general obligation bond for the Long-Term Care facility.

Moved Kreachbaum, second Placke to approve the chairwoman to sign Resolution 2025-10 stating the County has previously appointed a Board of Trustees for the Litzenberg Memorial Care Home. Approval for the construction of additions and improvements to the Nursing Home and desires to authorize issuance of general obligation bonds for the purpose of paying a portion of the costs of the project. Principal amount not to exceed \$6,950.000.00 and to levy taxes for payment of principal and interest on the bonds. Roll Call: Ayes-Dexter, Wiegert, Placke, Kreachbaum, Kucera; Nays-Weller and Jarecke. Motion carried with a vote of 5-2.

Discussion regarding the Secondary Well Source in Silver Creek resulted in the board not knowing of any effects on the natural resources under the County's jurisdiction. No action required.
